Subject : Regarding issuance of No Object Certificate for Transport & Non-transport Vehicles operated by Diesel and Petrol respectively.

Dear Sir / Madam,

Please refer to this office letter no. 2210(1)/STA/2016-11STA/2014 dated 28.11.2016. The matter of reconsidered due to some letters received for obtaining clarifications and after considering letters it has been decided by the department that in place of 37 districts only 33 districts should not be banned where NOC can be issued from NCR districts of UP and by any Registering Authority of any of the State or Union Territory of India.

2- In the light of above by office letter no 2210(1)/STA/2016-11STA/2014 dated 28.11.2016 a list of 37 districts in Schedule-A and a list of 38 districts in Schedule-B have already been communicated to you.

3- After suppression of the aforesaid letter 33 the districts of UP have been identified where No Objection Certificates for Transport or Non-Transport Vehicles may be issued. Such districts are as followed:-
